## NCA Presidential Address and Awards Presentation

The information environment has changed considerably since I was a young undergraduate researcher writing down Dewey Decimal numbers from the library card catalog. Immersed in higher education for several decades, I have seen tangible and significant effects from changes in technology, some of which I believe have serious consequences on our collective ability to address and resolve critical problems facing our world. In more recent times, as an officer of the National Communication Association, I have also come to appreciate and be critical of the role of scholarly associations in fostering an educational system that meets the needs of society. Larger than any local department or school, learned societies have an important role to play addressing what appears to be a descent back into an age of might over democracy, of fear over coexistence, and of isolated publics over mutual discourse. I will examine the impact of media environments on attention and focus, the reconfiguration of public space and political discourse by social media, and quirks of the changing professoriate, and I will attempt to provide suggestions for the future.

While there is controversy over the definitions and nature of a "dark age," there is no denying the possibility of a longer slide into chaos and authoritarianism. Loss of cultural memory and ignorance of the lessons of history are among the reasons why such an era could re-emerge in modern times, particularly given the potential impacts of the erosion of attention and the diminishment of engaged public discourse. Join me as I share my concerns and my hope, and look at the realities of the role of NCA and similar associations moving forward.

## NCA Day of Service

For the third consecutive year, NCA will be hosting a [Day of Service](#), sponsored by Kendall Hunt, on Wednesday, November 13. This year, we will be offering both a morning (8:00 a.m. to 12:00 p.m.) and an afternoon (1:00 p.m. to 5:00 p.m.) session.

The morning session will take place at Second Chance. Second Chance salvages usable materials from buildings being demolished, sells the material, and uses the revenue generated to provide job training and workforce development.

The afternoon session will be at the Boys & Girls Club of Metropolitan Baltimore (BGCMB). BGCMB serves more than 500 young people at one of its club locations.

Join us for one or both time slots, depending on your convention schedule. Transportation to and from the Hilton Baltimore will be provided. Lunch, and an opportunity to share your experience with others, will also be provided between the two sessions at the Hilton. There is a \$20 registration fee, but that will be refunded following the convention to all who attend the Day of Service.

You can register for the Day of Service when you register for the convention. ## All Gender Restroom

All-gender restrooms are available for attendees to utilize regardless of gender identity or expression. The designated restroom in the Baltimore Convention Center is located on the 300 level near room 341. The designated restroom in the Hilton is located on the second floor near Key Ballroom 9. ## Special Use Rooms at the Convention

Two rooms at the convention have been designated for special use. One room at the Baltimore Convention Center has been designated as a private area for lactation purposes. If you need to utilize this room, please go to the NCA Registration Desk to sign for a room key. The room must remain locked at all times for security purposes. The Baltimore Convention Center also has a nursing room, located on the 300 level.
