**INTRODUCTORY BUSINESS**

**Call to Order:** President Blair called the 2015 Legislative Assembly (LA) meeting to order at 12:02 p.m. Pacific time on Wednesday, November 18.

**Introductions:** Members of the LA were asked to stand and introduce themselves by name and the group represented.

**Credentials Report:** First Vice President Christina Beck announced that at 12:09 p.m. 128 delegates were registered from the 188 members of the LA.<sup>1</sup> *A motion was made that the roll of delegates submitted be the official roll of the voting members of this assembly. Seconded. Motion carried.*

**Standing Rules:** President Blair directed the body to the standing rules in the meeting binder. *A motion was made to adopt the standing rules as presented. Seconded. Motion carried.*

**Agenda:** President Blair directed attention to the proposed agenda. *A motion was made to adopt the agenda. Seconded. Motion carried.*

**ANNOUNCEMENTS**

The Legislative Assembly observed a moment of silence to honor those who have passed away during the past year.<sup>2</sup>

Scott Myers provided a report from the Educational Policies Board, John Greene provided a report from the Publications Board, Joseph Bonito provided a report from the Research Board, and Nancy Kidd provided a report from the National Office. Mark Fernando presented the report

of the 2015 Nominating Committee on behalf of Candice Thomas-Maddox.<sup>3</sup> Each of the candidates for Second Vice President addressed the Assembly.

## **BUSINESS**

**Election of the 2016 Committee on the Agenda:** The LA was asked for nominees for two positions on the 2016 Committee on the Agenda. Jimmie Manning and Shane Tilton were nominated. The candidates were declared elected.

**Nominations for the 2016 Committee on Committees:** The LA was asked for nominations for two positions on the 2016 Committee on Committees. Melissa Beall, Bernadette Calafell, and Heather Carmack were nominated. Each candidate was given one minute to address the Assembly. Ballots were submitted, and the President said that the results would be announced on Saturday.

**Job Ad Language:** President Blair introduces the proposal which is to amend the language in our current policy regarding required job ad language on domestic partner benefits in light of the recent Obergefell Supreme Court decision. *A motion was made to rescind the 2012 policy on job ad language. Seconded. Discussion ensued. Motion failed. A motion was made to amend the policy as specified in the LA meeting binder. Seconded. Discussion ensued. A motion was made to amend the first option under question #1 to cut "same sex and different sex." Seconded. Motion carried. A motion was made to insert "to" to the first options under question #2. There were no objections. A vote was taken to amend the current policy with the revision proposal in the LA meeting binder as amended. Motion carried.*

**Financial Reports:** President Blair introduced Finance Board Director Bobby Patton to present the financial reports. Patton talked about the financial results from FY14-15. He informed the LA that NCA received an unqualified opinion on our independent audit, which means our financial statements present fairly our financial position as of our fiscal year-end and the results of our operations for the fiscal year are in accordance with generally accepted accounting principles. He then talked about the implications of our statements of financial position and cash flow. Patton also referred the LA to the line-by-line comparison of the FY14-15 budget to actual revenue and expense, which was included in the meeting materials and shows that we ended the year with a small operating budget surplus. *A motion was made by the Finance Board to adopt the FY14-15 audit report. Discussion ensued. Motion carried.*

Patton then described the proposal for the FY15-16 operating budget. *A motion was made by the Finance Board to adopt the FY15-16 budget. Motion carried.*

**Constitution/Bylaws Revision:** President Blair introduced the proposal, the reasons for it, and its history. *A motion was made to consider the amendments to the constitution and bylaws. Seconded. Motion passed. A motion was made to 1) adopt the proposed bylaws to replace the current constitution and bylaws with the bylaws found in the LA meeting materials and 2)*

*initiative a membership ballot to rescind the current constitution, subject to a number of provisos regarding the transition period and a proviso indicating that if the membership fails to rescind the current constitution the LA vote to approve changes to the bylaws will be automatically revoked. Seconded. Discussion ensued. A motion was made to amend Article III Section 6 by inserting at the end "Recall of other elected Board members shall require a two-thirds vote of the Legislative Assembly." Seconded. Discussion ensued. A motion was made to close debate. Seconded. Motion carried. There was no objection from the body to a proposal that all amendments shall be subject to legal review and conforming amendments. A vote was taken on the amendment proposal. Motion carried. A motion was made to close debate on the main motion. Seconded. Motion failed. A motion was made to amend Article III Section 1 to strike "two Intercaucus Directors" and insert "one Director from each caucus." Seconded. Discussion ensued. A motion was made to close debate on the amendment. Seconded. Motion carried. A vote was taken on the amendment. Motion carried. A motion was made to close debate on the main motion. Seconded. Motion carried. A vote was taken on the main motion. Motion carried.*

**Adjournment:** President Blair adjourned the meeting at 4:00 p.m.

**Special Recognition:** President Blair recognized members of the association who have provided significant service to NCA. Outgoing Executive Committee members John O. Greene, Bobby Patton, and Kathleen J. Turner were recognized, as were outgoing editors Frederick Corey, David R. Dewberry, and Kate Hawkins. Presidential citations were given to Pat J. Gehrke and William M. Keith for their extraordinary work in editing NCA's Centennial Volume, *A Century of Communication Studies: The Unfinished Conversation*.

**Results from the Election of the 2016 Committee on Committees:** President Blair announced that Bernadette Calafell and Heather Carmack have been elected by the Legislative Assembly to serve on the 2016 Committee on Committees.

**2015 Committee on Committees Report:** Committee Chair Kathleen Turner announced the slate of candidates nominated by the committee.<sup>5</sup> *A motion was made by the Committee on Committees to adopt the slate of candidates as presented. Motion carried.*
