INTRODUCTORY BUSINESS

Call to Order: President Beck called the 2016 Legislative Assembly (LA) meeting to order at 12:03 p.m. Eastern time on Wednesday, November 9.

Introductions: Members of the LA were asked to stand and introduce themselves by name and the group represented.

Credentials Report: First Vice President Stephen Hartnett announced that at 12:09 p.m., 129 delegates were registered from the 188 members of the LA.¹ *A motion was made that the roll of delegates submitted be the official roll of the voting members of this assembly. Seconded. Motion carried.*

Standing Rules: President Beck directed the body to the standing rules in the meeting binder. *A motion was made to adopt the standing rules as presented. Seconded. Motion carried.*

Agenda: President Beck directed attention to the proposed agenda. *A motion was made to adopt the agenda. Seconded. Motion carried.*

ANNOUNCEMENTS

The Legislative Assembly observed a moment of silence to honor those who have passed away during the past year.²

Scott Myers provided a report from the Educational Policies Board, Bonnie Dow provided a report from the Publications Board, Joseph Bonito provided a report from the Research Board, and Trevor Parry-Giles provided a report from the National Office. Mark Fernando presented the report of the 2016 Nominating Committee on behalf of Mark Redmond.³ Each of the candidates for Second Vice President addressed the Assembly.

BUSINESS

Election of the 2017 Committee on the Agenda: The LA was asked for nominees for two positions on the 2017 Committee on the Agenda. Angie Corbo, Lori Britt, and Damion Waymer were nominated. Each candidate was given one minute to address the Assembly. Ballots were submitted, and the President said that the results would be announced on Saturday.

Nominations for the 2017 Committee on Committees: The LA was asked for nominations for two positions on the 2016 Committee on Committees. Sheena Howard (declined), John Katsion, Vincent Pham, Myra Washington were nominated. Each candidate was given one minute to address the Assembly. Ballots were submitted, and the President said that the results would be announced on Saturday.

Constitution/Bylaws Revision: President Beck introduced the proposal, the reasons for it, its history, and described the key proposed changes. *A motion was made to consider the amendments to the constitution and bylaws. Seconded. Motion passed. A motion was made to 1) adopt the proposed bylaws to replace the current constitution and bylaws with the bylaws found in the LA meeting materials and 2) initiative a membership ballot to rescind the current constitution, subject to a number of provisos regarding the transition period and a proviso indicating that if the membership fails to rescind the current constitution the LA vote to approve changes to the bylaws will be automatically revoked. Seconded. Discussion ensued. A motion was made to amend Article II Section 1.A striking “has been a member of the association for at least twenty-five years” and insert “is no longer working full time and has reached the age of 65 years or who is no longer working full time and has been a member of the association for at least twenty-five years.” Seconded. Discussion ensued. Motion failed. Discussion ensued. A motion was made to close debate on the main motion. Seconded. Motion carried. A vote was taken on the main motion. Motion carried.*

Recess for ten minutes

Reconvened at 2:10pm.

Proposal for New Division: Economics, Communication, and Society. The NCA constitution indicates that “divisions may be created by the Legislative Assembly upon receipt of petitions

signed by at least 100 members of the Association.” A petition with the requisite number of signatures has been submitted to request formation of an Economics, Communication, and Society Division. The Executive Committee reviewed this proposal and voted to forward it without recommendation for LA consideration.

Jeffrey Kurr introduced the proposal for an Economics, Communication, and Society division. Discussion ensued. *A motion was made to start a new Economics, Communication, and Society Division. Seconded. Motion carried.*

Financial Reports: President Beck introduced Finance Board member Orlando Taylor to present the financial reports as Finance Board Director Annette Madlock Gatison was unable to attend the LA meeting. Taylor talked about the association’s financial status from FY15-16. He informed the LA that NCA received an unqualified opinion on its independent audit, which means its financial statements present fairly its financial position as of the fiscal year’s end and the results of its operations for the fiscal year are in accordance with generally accepted accounting principles. He then talked about the implications of NCA’s statements of financial position and cash flow. Taylor also referred the LA to the line-by-line comparison of the FY15-16 budget to actual revenue and expense, which was included in the meeting materials and shows that the association ended the year with a small operating budget surplus. *A motion was made by the Finance Board to adopt the FY15-16 audit report. Discussion ensued. Motion carried.*

Taylor then described the proposal for the FY16-17 operating budget. *A motion was made by the Finance Board to adopt the FY16-17 budget. Motion carried.*

A motion was introduced that “a summary of funds that NCA invests in each year shall be available to the LA annually.” Seconded. Discussion ensued. Motion carried.

Discussion: Envisioning What’s Next. President Beck asked LA members to break out into small groups to reflect, share and record their thoughts and ideas on what’s next for NCA. President Beck asked members to reflect on the following questions: What should we, as an association, prioritize?; What goals should we set?; What ideas do we have for projects and possibilities that would help us to advance our discipline and serve our membership? Responses were recorded and collected for transcription and consideration.

Adjournment: President Beck adjourned the meeting at 3:06 p.m.

Call to Order: President Christie Beck called the 2016 Legislative Assembly meeting to order at 8:08 a.m. on Saturday, November 12.

Credentials Report: First Vice President Stephen Hartnett announced that at 8:04 a.m. 119 delegates were registered from the 185 members of the LA.⁴ *A motion was made that the roll of delegates submitted be the official roll of the voting members of this assembly. Seconded. Motion carried.*

Special Recognition: President Beck recognized members of the association who have provided significant service to NCA. Outgoing Executive Committee Members Carole Blair, Joseph A. Bonito, and Annette Madlock Gatison as well as outgoing editors Barbara Biesecker, Peter Decherney, Kory Floyd, Pat J. Gehrke, Rona Halualani, Marian Houser, and Katherine Sender. Presidential citations were given to Keith Berry and Renee L. Cowan for their extraordinary work as Co-Chairs of the Anti-Bullying Task Force; Nancy Kidd for her extraordinary work as NCA Executive Director from 2009 to 2016; and to Mark Fernando for 10 years of loyal service to NCA.

Results from the Election of the 2017 Committee on the Agenda: President Beck announced that Damion Waymer and Lori Britt have been elected by the Legislative Assembly to serve on the 2017 Committee on the Agenda.

Results from the Election of the 2017 Committee on Committees: President Beck announced that Myra Washington and Vincent Pham have been elected by the Legislative Assembly to serve on the 2017 Committee on Committees.

Membership Category Discounts. President Beck introduced Bonnie Dow to present a proposal on behalf of the Executive Committee of the LA to offer membership discounts to specific groups of people with low income. Discussion ensued. *A motion was made to amend the proposal and add “part-time and contingent faculty as an additional membership category discount for 2016.”* Discussion ensued. *A motion was made to amend the amendment to change “2016” to “2017-2019.”* Moved without objection. *A motion was made to close debate. Seconded. Motion carried. A vote was taken on the amendment. Motion failed.* Discussion ensued. *A motion was made to close debate. Seconded. Motion carried. A vote was taken on the main motion. Motion carried.*

Dues increase policy. President Beck reintroduced Bonnie Dow to present a proposal on behalf of the Executive Committee on the LA to establish a policy to raise the dues of regular membership every three years commensurate with inflation. The following policy language was proposed: *Every three years, dues for regular membership will be raised commensurate with inflation. The dues amount will reflect the inflationary increase rounded to the next highest dollar.⁵ Should a more frequent and/or higher increase be sought at any point, a specific proposal would have to be brought to the LA for consideration.* Discussion ensued. *A vote was taken on the proposal. Motion carried.*

2016 Committee on Committees Report: Committee Chair Carole Blair announced the slate of candidates nominated by the committee.⁶ *A motion was made by the Committee on Committees to adopt the slate of candidates as presented. Motion carried.*
